PURCHASER WARRANTS TO SELLER (1) That the burial plot described herein is (a) owned by purchaser or (b) purchaser has the right of access to and from the plot, the right to grant seller access to and from the plot, and does hereby grant seller such access to install the monument or marker which is the subject of this contract. (2) That should purchaser fail to pay for the monument or marker as agreed, purchaser further hereby authorizes seller to enter upon said burial plot and remove the monument or marker. (3) Purchaser further agrees to indemnify seller and hold seller harmless from any claim whatsoever by the cemetery, adjacent plot owners or claims of any person, firm or corporation resulting from seller's actions under this contract, and purchaser shall be responsible to seller for all costs incurred by seller in defense of such claims including reasonable attorneys fees.

PURCHASER INSTRUCTS the cemetery at which the installation or removal is to be performed to cooperate with seller to provide seller with reasonable access to the gravesite and to extend to seller all rights of access enjoyed by Purchaser as though Purchaser himself/herself were going in, about, on or over the premises in question.

PURCHASER AUTHORIZES AND INSTRUCTS the cemetery, its officers, servants and/or employees to give and to provide unto seller such information as is required in seller's sole discretion to enable seller to adequately perform the work and/or service contemplated hereby.

In regard to purchaser's instructions and authorizations to cemetery purchaser specifically indemnifies and agrees to hold the cemetery, its agents, servants, and/or employees harmless from any claims whatsoever based upon the giving of information to seller by the cemetery under the terms hereof or in granting seller access to the plot including any and all costs of defense of any such claims and reasonable attorneys fees.

All lettering and other work after the setting or erection of the memorial in cemetery is to be paid for extra. This order subject to any delay by fire, lockout, strike or any other condition beyond our control.

Any part of this agreement contrary to the laws of any state shall not invalidate any other part thereof.

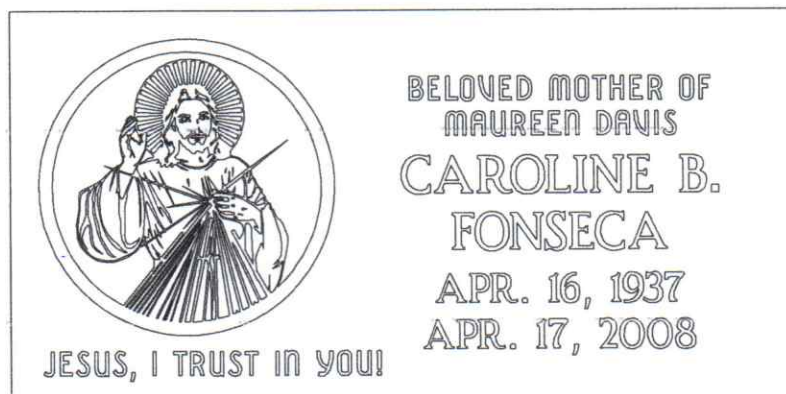
The said memorial is guaranteed by the seller against any defect in material or workmanship.

Contract Addendum

Process and Procedures

1. Monument selection and design
2. Monument completion: we call all customers after we complete the work
3. Balance paid and grave flagged by the customer if needed using the flag we provide. Flags are provided after the stone is completed.
4. Monuments are installed/delivered within 2-8 weeks, weather permitting, after completion and/or after grave is flagged. *bkw* (please initial)

We call all customers to notify them the stone has been installed or delivered.
*****We DO NOT give installation dates in advance due to weather and other circumstances beyond our control.****

5. We DO NOT make arrangements for family to be present at the cemetery during installation for the following reasons:

- A. Unpredictable weather
- B. Safety due to heavy equipment and/or machinery usage by our team
- C. Circumstances beyond our control

Estimated Delivery Date

The estimated delivery date is the date we are working towards for completing your monument. However, due to delays with 3rd and 4th party vendors and occasional equipment malfunctions; we may take additional time beyond the estimated delivery date to complete the monument. Memorial Payment Plan Policy

In an effort to assist our customers in purchasing monuments, Honest Monument Company (HMC) offers the following Memorial Plan Policy:

A purchase will be classified as a "Memorial Payment Plan" when the initial payment at the time of purchase is less than the total purchase price. The following terms and conditions must be adhered to by the HMC customer.

- No monument order placed using the Memorial Plan will be completed until the total balance has been PAID IN FULL.
- The production and completion of the monument will occur within 6-8 weeks after the final payment.

- Price increases for monument cost and cemetery fees will be added to purchase price before final payment is made by the customer.
- Custom monuments including special shapes, designs and colors may take up to 12 weeks or more for production and completion *bkw* (please initial)
- Any changes made to orders while in the Memorial Payment Plan may require additional cost, production and completion time.
- Upon completion, monuments will be placed in rotation for installation. Express installations will require additional payment to be paid at the time of the request.
- Memorial Plan payments are to be paid monthly. Failure to make a payment within a 6 month period will forfeit your Memorial Plan. Deposits and payments will not be REFUNDED *bkw* (please initial)
